

Provider Search Window (This is used to search placement providers for children in out of home care.)







FSFN - General Search Screen Shots

WILD CARD SEARCH

If you are not sure how to spell the person's name you can do a "wild card" search:

- Enter only the letters that are known and end by adding a wildcard* (asterisk)
- Asterisk must not be the first character
- FSFN returns all names that have letters in common
